# National HIV Goals, Vision, and Priority Populations



## Goals

The Strategy focuses on four goals to guide the nation toward realizing this vision:



**GOAL 1**  
**Prevent New HIV Infections.**



**GOAL 2**  
**Improve HIV-Related Health Outcomes of People with HIV.**



**GOAL 3**  
**Reduce HIV-Related Disparities and Health Inequities.**



**GOAL 4**  
**Achieve Integrated, Coordinated Efforts That Address the HIV Epidemic Among All Partners.**

## Strategy Vision

The United States will be a place where new HIV infections are prevented, every person knows their status, and every person with HIV has high-quality care and treatment, lives free from stigma and discrimination, and can achieve their full potential for health and well-being across the life span.

This vision includes all people, regardless of age, sex, gender identity, sexual orientation, race, ethnicity, religion, disability, geographic location, or socioeconomic circumstances.

## Priority Populations

- Gay, bisexual, and other men who have sex with men, in particular Black, Latino, and American Indian/Alaska Native men
- Black women
- Transgender women
- Youth aged 13–24 years
- People who inject drugs



# Integrated HIV Prevention and Care Plan

- Required by CDC and HRSA every 5 years
- Current plan was developed in 2016- in place from 2017-2021
- Guidance for new plan released in June 2021
- Final plan for 2022-2026 due for submission December 9, 2022
- Internal Goal: Finalize draft of integrated plan by **October 10, 2022** for internal review

# Why Integrated Planning?

- Ensures collaboration among HIV prevention, care, STI, and harm reduction public health staff
- Creates opportunity for alignment of strategies and plans- STI, HIV, and HCV
- Ensures input from community partners in our planning efforts:
  - SAPG
  - Local Health Departments
  - Agencies funded to provide services
  - Communities impacted by HIV, STIs, HCV
  - Organizations that provide HIV, STI, and Harm Reduction Services

# Integrated Plan Goals

- Wisconsin goals will mirror goals in the National HIV/AIDS Strategy (NHAS)
  - Goal 1: Prevent new HIV infections
  - Goal 2: Improve HIV-related health outcomes of people with HIV
  - Goal 3: Reduce HIV-related disparities and health inequities
  - Goal 4: Achieve integrated, coordinated efforts that address the HIV epidemic among all partners

# Goal Workgroup Tasks

- Responsible for developing objectives, strategies, and activities for each goal for inclusion in the Integrated Plan (Section V)
- Responsible for gathering input from SAPG specific to the goal
- Responsible for getting feedback on objectives, strategies, and activities from external partners and community members

# Developing Objectives, Strategies, Activities

- How will we do it?
  - Template
    - At least two objectives for each goal
    - At least three strategies for each objective
      - For each strategy, an accompanying narrative describing the strategy and at least three activities that address the strategy. The activities should include priority populations, responsible parties, timeframe, and data indicators
  - SAPG meeting- focus on each goal
  - Gathering feedback and incorporating it into template
  - Focus on incorporating health equity into objectives, strategies, and activities

# Integrated Needs Assessment

- Diverse & Resilient contracted to complete Integrated HIV Prevention and Care Needs Assessment- report delivered on April 11, 2022
- Two surveys- a community survey (126 respondents) and a provider survey (83 respondents)
- Focus group- 26 participants

# Key Needs Assessment Findings Related to Goal 1

- At-Home HIV Tests
  - Majority of respondents never used an at-home HIV test but also said “yes” or “maybe” they would be interested in using one
- Condom Use
  - Only 12% of respondents report using condoms during vaginal/anal sex every time, while 25% report never using condoms for vaginal/anal sex
    - 52% report never using condoms for oral sex while only 5% say they always use condoms during oral sex
  - 95% of respondents say they have easy access to condoms when they need them

# Key Needs Assessment Findings Related to Goal 1

- Syringe Services
  - 28% of respondents use syringes to inject drugs, and 18% shared syringes; 91% report using sterile equipment every time or most of the time
    - Of PWID respondents, 57% share needles sometimes to most of the time, 11% are HIV positive (25% not in care)
  - 89% indicate they know where to get sterile equipment/supplies in their area and a majority (73%) are “extremely” or “quite” comfortable going to a syringe services program

# Key Needs Assessment Findings Related to Goal 1

- Social Determinants of Health
  - Employment, Housing Stability, Access to Care/Insurance, Stigma, Mental Health, Safety, Experiences of Oppression, and Transportation all identified as barriers to achieving care outcomes
- Telehealth
- Majority of respondents said “yes” or “maybe” that telehealth would be a good option for them

# Key Needs Assessment Findings Related to Goal 1

- PrEP/PEP
  - Large majorities of priority populations have heard of PrEP (85% of total respondents), but only 12% indicated they are currently taking it
    - 36% of total respondents indicated they “would not be interested in taking PrEP” even if they feel they are at risk for HIV
  - Large majorities of priority populations have heard of PEP (75% of total respondents), and 68% indicate they would know how to obtain it
