State and National Updates

2021-23 Wisconsin Biennial Budget

- Gov. Tony Evers presented his biennial Wisconsin state budget on February 16, 2021
- \$91 billion two-year spending plan
- Key priorities:
 - ◆ COVID-19 economic recovery
 - ◆ College affordability
 - ◆ K-12 Education
 - ◆ Criminal justice reform
 - ◆ Unemployment system upgrades
 - ◆ Ending Act 10 restrictions on some collective bargaining
 - ◆ Equity and inclusion initiatives
 - ◆ Public health



Investing in Public Health

- Governor Evers' budget would:
 - ◆ Create and fund 23 new epidemiologist and public health educator positions in the Bureau of Communicable Diseases
 - ◆ Increase funding for local public health communicable disease work
 - ◆ Create a harm reduction strike team consisting of 3 staff
 - ◆ Add 5 disease intervention specialists for statewide HIV/STI follow-up
 - ◆ Increase grant funding for community health centers
 - ◆ Create new health equity and minority health grants

Budget Next Steps

- February-June: State lawmakers hold hearings and rewrite sections of budget
- June 30: Current biennial budget ends
- Gov. Evers can accept lawmakers' changes or use partial veto to make additional changes

New Department of Health Services Secretary

- Secretary-Designee Andrea Palm joined the Biden administration in January
- Gov. Evers tapped Karen Timberlake to be the interim Secretary of the WI Department of Health Services
 - ◆ Previously served as Secretary of DHS under Gov. Jim Doyle from 2008-2011



PrEP Updates

- 6 generic drug manufacturers have received FDA approval to market PrEP as a generic
 - ◆ Should be available on market in May-June
 - ◆ Will reduce price of medication by 85-90%
- Beginning January 1, PrEP is covered by all private insurers and Medicaid with no cost-sharing, including labs and office visits

Cabenuva

- FDA approved Cabenuva as the first approved injectable, complete regimen for PLWH who are virally suppressed

Administered once a month

- Safety and efficacy established through two randomized, open-label controlled clinical trials in 1,182 PLWH who were virally suppressed
- Cabenuva is manufactured by Viiv Healthcare

HIV National Strategic Plan

- HHS released National HIV Strategic Plan on January 15, 2021

- Four Goals:
 - ◆ Prevent new HIV infections
 - ◆ Improve HIV-related health outcomes for people with HIV
 - ◆ Reduce HIV-related disparities and health inequities
 - ◆ Achieve integrated and coordinated efforts that address the HIV epidemic among all partners and stakeholders
